2010 SEASONAL FIELD/COURT RENTAL APPLICATION

1. **Seasonal permits will be issued for a 10 week period.** Please allow for rain make-ups and playoffs in your schedule. The season rental periods are as follows:
Spring Seasonal Permits dates begin **Monday, April 5, 2010.**
Summer Seasonal Permits dates begin **Monday, June 14, 2010.**
Fall Seasonal Permits dates begin **Monday, August 23, 2010.**
2. ☆ **LTP&R reserves the right to delay the start of the season due to unplayable field conditions.** LTP&R also reserves the right to recall use of a specific field or court at a specific time with a minimum **24-hours notice given to the permit holder.** In this case, LTP&R will offer alternate open make-up dates.
3. Requests for facilities beyond a 10 week period will be handled on an individual basis with a fee per date charged. These additional facilities may be arranged for at the same time the seasonal permit is issued (**at a cost of \$25 per permit per additional date**).

Seasonal Field/Court Rental Fees: (Seasonal rentals include a 10 week rental schedule)

| 2. Single Nights (added to seasonal permit) | \$25/night assigned per field |
| 3. Use of Storage Shed at LCP (3 groups per season) | \$100.00 for the season /\$25 (refundable- key deposit) |
| 4. Security Deposit (refundable) | \$250/league or team & insurance certificate |
| 5. Seasonal Rental Application Fee | \$25.00 (must be submitted with application) |

Fields/Courts are assigned by first come, first serve basis for the upcoming season. Please fill out the application completely and return with a \$25.00 application fee (which will be deducted from your total amount due on your permit). Checks should be payable to "Limerick Township".

Note: There is NO guaranteed assignment, even if you meet the submission dates. LTP&R will make every effort to assign facilities in an equitable manner while maximizing usage and number of groups satisfied.

PLEASE NOTE: Additional Information needed on file once permit is issued – copy of insurance certificate, 2010 practice and/or game schedule for field, coaches' name and contact information who is using the fields and a separate check for \$250.00 which is a refundable security deposit once your permit is completed.
