- Ways to Register: Mail-In or Walk-In. LTP&R hours are Monday - Friday: 8 am - 4 pm. Address: 646 West Ridge Pike, Limerick, PA 19468
- Classes are filled on a first come first served basis...register early.
- Pre-registration is required for all programs unless otherwise noted.
- Payment must accompany registration form. Cash, Check or Credit Cards are accepted. Please make checks payable to "Limerick Township"
- Insufficient Funds: A \$20 charge will be charged back to participant for each returned check.

Signed Registration /Hold Harmless forms are required for participation in LTP&R programs/trips - these forms are a contract of understanding between you and LTP&R. Signed registration forms are required to process your registration and for participation in recreation programs/trips.

NEW! Credit Cards are now accepted for LTP&R programs and trip registrations!

MasterCard, Discover & Visa are accepted. A third-party convenience fee will apply to cardholders who wish to pay via credit card. This fee is required in order to allow the Township the option to accept payments via credit card. Such fee will be disclosed to cardholder at time of transaction with the option to decline the fee and make payments via cash or check. Nationwide Payment Solutions is an authorized Level 1 PCI-DSS third-party processor of these regulated convenience fees. This fee will be 2.45% (\$1.50 Minimum). A Flat Fee of \$3.95 applies to all payments made using a Visa Consumer Check Card.
