Message from the Chairwoman



On Saturday, October 27th, the community gathered to dedicate the new Limerick Township Municipal Building. It was a wonderful event which celebrated the opening of this new facility, but more importantly, ushered in a new era of service to the Township. For many years, our police department labored in an outdated building that could not accommodate the growing force, which now stands at 30 sworn officers. This new municipal building will now provide our police department and administrative staff with modern training and operational space, tools, and technology to meet the growing challenges as they protect and serve this growing and vibrant community.

The design of the new building met a key Board objective: that the facility accommodates operational growth for the next several decades. We are confident this goal has been achieved and this long-term approach to serving our community will now focus on other township services, specifically the parks and recreational programs and road safety improvements.

In terms of roadway projects, new designs are underway for the intersection of Royersford and Linfield-Trappe Roads, the intersection of Township Line and Linfield-Trappe Roads, and sidewalk and storm-water improvements on North Lewis Road.

With the completion of the Master Plan for Limerick Community Park this year, due to the addition of 25 acres dedicated to the Township by the Sankey family, a fresh long-term plan is now in place. The implementation of the new Master Plan will not happen overnight, but will require many years of dedicated effort as we leverage state and federal grant monies to offset township funding required to make this new park plan a reality for our residents of today and tomorrow. The Board has authorized grant applications for Phase One improvements in 2019 to begin the initial work which will ultimately lead to expanded playing fields, trails, walking paths, a community center, and parking areas. The Master Plan, including the detail on the various construction phases, is available for viewing on the Township website.

The Board has been very successful in the past with obtaining grants and utilizing alternate funding sources and we are confident that our continued efforts over the next few years will result in similar cost assistance on all of these capital heavy projects.

Also in 2019, we will continue our long-term planning efforts and look to enhance the recreational offerings within Linfield. Our volunteers on the Parks and Recreation Committee will begin work with the planning staff on new ideas and concepts for Linfield Sports Park, ultimately linking this park with a trail network to other township lands along the Schuylkill River.

The Township is always seeking new volunteers, and if you would like to participate in these recreational planning projects or if you can offer your time in other ways, please contact our township staff at the new municipal building and they will be happy to review all opportunities.





Highlights of the Township Municipal Building

Limerick Historical Society's Veterans Monument Project

Currently, in Limerick Township there are monuments honoring veterans who served during World War I and World War II. The Limerick Historical Society is working on adding monuments to honor veterans who served starting with the Korean War to the present day War in Afghanistan and Iraq.

The basic criteria to have a name on the monument is that the veteran must have lived in Limerick Township when his/her service began or a person may have been raised in Limerick Township and entered the military after completing school. Veterans who lost their lives during the war while they were serving, will receive a special indication on the monument. In addition, to the basic information, the Historical Society is interested in collecting biographies of veterans from any time period to preserve in their library.

Township Volunteer Spotlight


Mark John

WINTER REMINDERS

- Do not drive unless it is absolutely necessary. If a state of emergency is called, please stay off the roads so the plows can do their job without any more danger.
- Keep winter driving aids (blanket, shovel, boots, etc.) in the trunk of your car.
- Remove snow, ice, and slush from sidewalks, including handicap ramps, within 24 hours after the snow has stopped falling.
- Plowing operations begin after more than 2" accumulation and freezing temperatures, which indicate no natural melting will occur.
- Clear vehicle completely of snow and ice before driving.
- Pile snow from sidewalks and driveways on lawns, not in the street.
- Residents are responsible for clearing snow around mailboxes.
- Basketball hoops are *not permitted* to be located within the right-of-way and *must be removed* from the roadway.
- Private plowing crews should haul snow from properties if it cannot be piled safely.
- Do *not* push snow onto the street or onto neighboring properties.
- Clear fire hydrants of snow as soon as possible.
- As the storm begins to come to an end, plow units are pushing open all roads curb to curb which is to allow for another storm. Please refrain from completely clearing your driveway until that truck makes its last pass due to the fact that it will be plowed over.

Christmas Tree Recycling Drop Off


Christmas trees may be dropped off for recycling at the designated area at the Limerick Community Park


