

# SCHOOL DISTRICT PROPERTY TAX / RENT REBATE PROGRAM EXTENDED

Dear Taxpayer,

June 30, 2025

I would like to take this opportunity to inform you about the extension of the Property Tax/Rent Rebate Program instituted by the Spring-Ford Area School District. At the April 28, 2025 Board meeting, the Spring-Ford Area School District Board of School Directors unanimously approved the extension of the Property Tax/Rebate Program that will allow eligible homeowners and renters to receive an additional rebate of up to 50% of the Pennsylvania Property Tax/Rent Rebate.

The School District Property Tax/Rent Rebate Program is IN ADDITION to the existing Pennsylvania (State) Tax/Rent Rebate Program, which has been in effect since 1971 and is funded by the state lottery and slot machine proceeds.

## All 3 of the following requirements must be met to qualify:

1. Spring-Ford homeowners and renters must qualify for the state rebate program to qualify for the school district rebate program.
2. Applicants must be age 65 or older; widows and widowers age 50 or older; or people with disabilities age 18 or older.
3. The income limit is \$46,520 per year for homeowners and renters — HALF of Social Security income is excluded.

If you feel you may qualify for this additional rebate program, the application form is included on the next page, at my office during window hours, and the School District website.
