Message from the Chairman

Congratulations to new Police Chief Robert Matalavage, we look forward to the continued leadership he brings to the department. We also thank Chief Brian Skelton for his 32-years of service and wish him a happy and healthy retirement. Both Brian and Bob began their police careers here with Limerick. Through their many years of service beginning as a patrol officer and then as Sergeant and Lieutenant, each gained valuable experience that helped them succeed in their role as Chief. We continue to focus on training for the next generation of leaders to ensure they can succeed and follow this model including newly promoted Lieutenant Patrick Roche, Sergeant Stephen Winneberger and Corporals Michael Hull and James Reilly. All have demonstrated the necessary leadership skills to serve within the department's command staff. We congratulate them and look forward to the contributions and service they will bring to the department and this community.

I am also pleased to report that the Township is approaching full staffing levels across all departments, which were below approved budgeting levels for a few years, due to attrition and Covid-related issues. All new team members will help the Township provide our residents and business community with the high-level of services that this community has become accustomed to.

Over the past several years, efforts to strengthen police, public works, fire protection, parks and open space services have proven successful and have not negatively impacted the Township financial structure. This same philosophy will now be extended to Emergency Medical Services (EMS) as we begin to work with the newly formed Freedom Valley Medical Rescue organization highlighted in this newsletter. All EMS organizations continue to struggle across the country as insurance reimbursements dwindle due to healthcare regulations. PA laws mandate local municipalities to be financially responsible for EMS services and Limerick will be required to support Freedom Valley at a higher level to ensure this new organization can continue to provide high-level emergency medical services to the township. Projections show that increased attention to both fire and EMS services will be warranted as volunteer staffing, outside funding, inflation and cost of services will strain these vital service organizations. The Board continues to discuss the need to amend insurance regulations with our state and federal elected officials, so the burden of these vital emergency services is not so heavily reliant on local taxpayers.

Introducing...

Freedom Valley Medical Rescue

If you haven't heard, Harleysville Area EMS and Trappe Ambulance merged to provide regionalized coverage and now operates under the name, Freedom Valley Medical Rescue (FVMR). The merger will reduce operating costs and establish a long-term, sustainable organization that can meet the challenges confronting EMS providers across PA.

The primary struggle EMS organizations face is declining funding from healthcare insurance providers which is forcing them to reduce operating costs to keep their doors open. Many ambulance companies cannot pay adequate wages to maintain the highly skilled EMS first responders who provide the lifesaving services that the community expects and deserves.



PA laws must be changed so healthcare insurance companies are mandated to pay their fair share to EMS organizations such as FVMR, who provide emergency medical services to those they cover. To close the funding gap, EMS organizations are now turning to local communities for support since PA laws now mandate that municipalities are financially responsible for ambulance and fire services.

How will the merger benefit you? While continuing to receive quality emergency service response, Limerick's increased financial contribution will recognize all Township residents as subscribing members of FVMR. This membership status will provide that no residents will be solicited for subscriptions or be billed for ambulance costs not covered by their insurance company. This is a \$90 savings for those who paid such a subscription to Trappe Ambulance in the past.

FVMR will continue to operate out of the Limerick Fire Station on Ridge Pike as well as from their Harleysville, Phoenixville, Trappe, and Green Lane stations. It is projected that FVMR will respond to 6,000+ emergency calls annually!

A message from Freedom Valley Medical Rescue:

Freedom Valley Medical Rescue looks forward to continuing to work with each of your municipalities and continue to provide a professional emergency pre-hospital Ambulance service to the community. In establishing FVMR, we not only focused on a service delivery model that is professional, high quality and cost efficient, but also has long-term sustainability as a pre-hospital emergency medical care organization. We believe working together with our municipal stakeholders in an open and transparent partnership will lead to a successful organization.

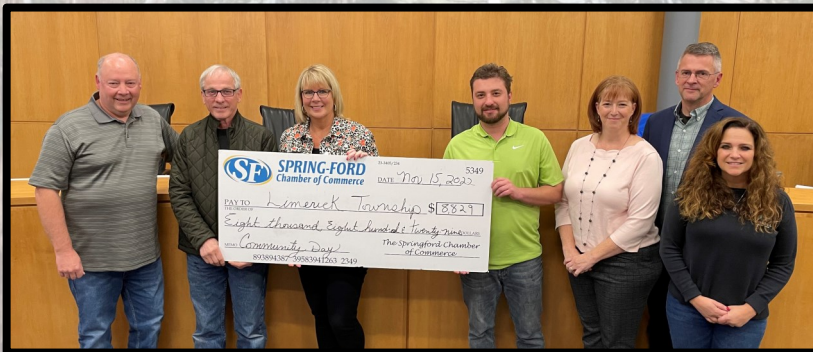
Recognitions

Jim Lucas - Receives PA Building Code Official of the Year Award

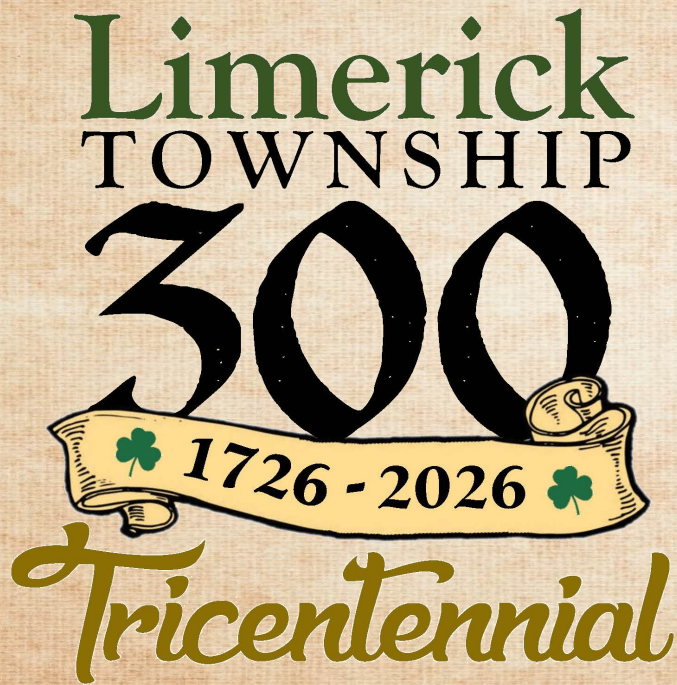

Lieutenant Robert J. Matalavage promoted to Chief

The Board of Supervisors and Limerick Township is pleased to congratulate Lieutenant Robert J. Matalavage on his promotion from Lieutenant to Chief of Police. Bob began his career in 1986 as a police officer for Wernersville and also as a part-time officer for Limerick Township. He became a full-time officer for Limerick Township in June, 1987, and has risen through the ranks from patrol officer to Corporal to Sergeant and onto Lieutenant. He started the first K-9 unit in July 1990, and was also a K-9 officer through 2008.

Bob is a graduate of St. Pius X High School and the Reading Police Academy. In addition to his extensive training, he is a graduate of the Police Staff and Command from Northwestern University. He holds both a LEEDA Trilogy Award through the FBI Law Enforcement Executive Development Association and Penn State POSIT and POLEX programs. Bob was sworn in as Chief earlier this year on August 2nd by Magisterial District Judge Welsh. He is responsible for 30 sworn officers and ensures the operations of the entire Police Department are functioning properly. Congratulations, Chief Matalavage, and thank you for continuing to serve and protect the citizens of this great community!

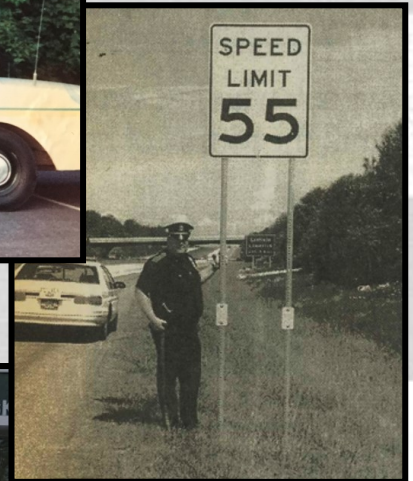

Since then, the department has grown to 30 officers and 4 civilian staff. Chief Skelton is looking forward to retirement spent with his wife, his children, and his grandchildren. 12/26 through 01/31.**

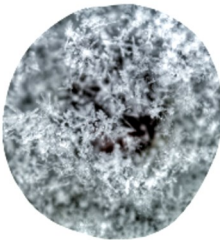

Reducing Pollution This Winter

What you can do to prevent stormwater pollution
on your property

1) Shovel as soon as possible after a snowstorm. As a result, less ice will form and you won't need to use as much salt or de-icer.



2) Use safe and effective alternatives to salt. Remember that salt is not effective below 15 degrees Fahrenheit. Sand or kitty litter will give you traction when it's too cold for salt.



3) Plant native species, that are salt tolerant, near paved areas. Not only will these species be able to survive despite the road salt, they will also act as a protective buffer for local waterways.



4) Make sure the storm drains closest to your property are clear of snow and other debris. Do not shovel snow into storm drains since they empty directly into local creeks.

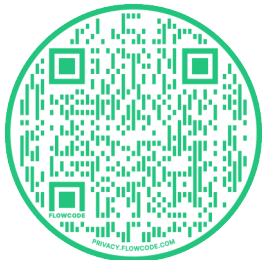
