Message from the Chairman

Ensuring that our Limerick community is provided with the highest level of public safety services remains a primary objective of the Board. This is evident with the financial support structure the Township has in place with the Limerick Fire Department, which is an organization made up entirely of volunteers.

Gone are the days when a local volunteer fire department could sustain themselves financially with fund drives and ham dinner types of events. The cost of equipment, vehicles, and training has escalated to a point that has crippled the volunteer structure, which has been the backbone of local fire departments for decades.

The Township's assistance to Limerick Fire Department has helped strengthen our volunteer base, in contrast to the steady decline many other fire companies are experiencing. The volunteers who dedicate their time and talents to protect this community save our taxpayers approximately \$4 - 5 million **annually** by not having to fund paid staffing.

Strong operational procedures have reduced costs and redundant equipment without a reduction in the life-saving services our volunteers provide. *Since 2008, there has not been an increase in the millage rate of the real estate fire tax collected by the Township to support the Limerick Fire Department.*

The Board is confident that the volunteer structure can be maintained and discussions with the Limerick Fire Department on future needs will be ongoing this fall in preparation of the Limerick Township 2024 Budget.

The amount of time our volunteers dedicate to the fire service and this community is beyond measure, and they deserve our continued support.

Current news reports, in Pennsylvania and across the country, are highlighting the increasing struggles of Emergency Medical Service (EMS) organizations and closures of many long-standing providers. Increasing costs, lower insurance reimbursements, and dwindling personnel (not willing to work at below-average wage positions) are all crippling this vital EMS industry.

Similar to what we have done with the Limerick Fire Department, the Township has been working with our local ambulance providers on a sustainable financial support structure so they can continue to provide life-saving services to all within this township. These EMS issues, in conjunction with the fire department issues, will be a major topic of discussion during the 2024 Budget process.

The financial struggles they face cannot be ignored.

We are assured that solutions can be attained so the lifesavings services they provide will not only continue for our community today, but be strengthened for all who will call Limerick home in the future.

We wish everyone a wonderful fall season.

Protecting our Community

Of the 89 fire companies within Montgomery County, Limerick was the 7th busiest in 2022 with approximately 800 emergency responses. Limerick is the only one in the top ten fire companies that remains all volunteer. This all volunteer structure provides an annual savings to the Limerick taxpayer of \$4 - 5 million, because paid personnel are not required.

On average, a Limerick Fire Department (LFD) volunteer offers 60 hours of their time monthly, not only in responding to emergency calls, but in training, apparatus, equipment, and facility maintenance, as well as participating in fundraising and community events. The volunteers also manage the business operations of the Fire Department and the budget challenges of maintaining their life-saving services with the ever-increasing inflationary costs that are impacting us all.

EMS - Working towards a sustainable solution

Across the Commonwealth, Emergency Medical Services (EMS) agencies are struggling to keep their doors open and ambulances responding to calls. Funding challenges brought forth by dwindling insurance reimbursements and increasing operational costs threaten the long-term viability of our emergency service providers. Without dedicated funding from Harrisburg, or changes to insurance reimbursements, the burden is falling on local municipalities to sustain this vital life-saving service. **We can no longer take for granted that an ambulance will respond when that 911 call is made.**



- WE CANNOT ALLOW EMS TO FAIL -

Limerick Township is acting!

- Partnering with a multi-municipal program on options to fund EMS agencies that serve our communities jointly to reduce the cost burden of each community individually.

We can't help you, if we can't find you



Your address number must be clearly displayed. It's not only for your safety... it's the law.

Whether mail is delivered to your home or you use a post office box, your address needs to be clearly posted on your property.

When first responders are dispatched to a given location, they may be delayed in arriving if the address is not clearly seen from the street. Although it's fairly easy to spot a column of smoke from a house fire, it's difficult to see someone's heart attack from the street. In a medical emergency, they may waste critical time having to knock on several doors to

try and find a correct address. Make sure your address is clearly visible from the street. The numbers should be three or four inches in height and be reflective.

The numbers must be visible from the road. Put numbers on your house under a light. **Numbers on your mailbox should be reflective and should be visible from both sides of the mailbox, because emergency vehicles may come from either direction.**

If two or more houses share a long driveway, all numbers should be posted at the end of the driveway and each house should have its own number posted on the house. All units in mobile home parks must also be addressed. If there are any bushes, vines, flowers or trees planted near the area where the numbers are posted, make sure they are trimmed so the numbers can be seen clearly at all times.

A clear driveway is also extremely important for larger emergency vehicles, such as firetrucks, that need to get as close to your home as possible. Remember, time is critical. A fire doubles in size every 30 seconds. If the fire department cannot get close to your structure, they have to stretch hose by hand which consumes valuable seconds.



Clear trees, branches or brush from your driveway so it is at least 12 feet wide with a vertical clearance of at least 13.5 feet to allow fire trucks access to your property.

Ensure your driveway's surface is firmly packed and can support the weight of emergency vehicles, even in the spring when the ground is soft.

Remove gates, fence posts or other obstructions that could restrict access.

Q & A with Ryan Wall

What tax bills do I pay to the Limerick Township Tax Collector? I collect the County/Township Real Estate Tax bill in the spring and the Spring-Ford School District tax bill that comes out in the summer.

How do I go about paying my taxes? Tax payments are collected in many forms to accommodate everyone: Checks- Are accepted up until December 15th each year and should be made payable to: Ryan Wall, Tax Collector. They can be dropped off 24/7 in the drop-box located in the Township Building's front vestibule, or by mail. Credit Cards or eChecks- Can be paid through Municpay, however, there are fees associated with these forms of payment. Go to the Tax Collector Department page of the Township's website and click on the "Ways to Pay" box for more information. www.LimerickPA.org

I have a mortgage with an escrow account for payment of taxes, do I need to forward my Real Estate Tax Bills to my mortgage company? All real estate bills (County/Township and School District) are sent directly to the property owner(s); most mortgage companies request these bills as well, and you usually do not need you to forward them, however, it is always a good practice to check with your mortgage company to find out for sure which method they prefer. ***It's also prudent that you check your monthly mortgage statement to make sure a disbursement was made from your escrow account.***

Note: If you receive a bill marked INTERIM tax: You need to send these to your mortgage company as mortgage companies do not automatically ask for or receive these bills.

Who do I contact with questions about Earned Income Tax? BERKHEIMER- Visit the Berkheimer Taxpayer Resource Center at: <https://www.hab-inc.com/contact-us>. Also check the FAQ section on my Department page on the Township's website.

Does Limerick Township have a per capita tax? No. Some municipalities do, Limerick does not.

I recently changed my name and/or need to update my mailing address. Who do I need to contact to make sure the bills get sent to me? The County needs to update this information in their system. Contact the Montgomery County Board of Assessment Appeals at 610-278-3761.

Pennsylvania Legislature passes expansion on Property Tax/Rent Rebate starting in 2024.

Thanks to the passage and signing of HB 1100, the income limit will rise from \$35,000 to \$45,000 for homeowners and renters, and the maximum rebate will increase to \$1,000. There's also a cost-of-living adjustment that will keep pace with inflation. Raising the income limit is expected to help nearly 175,000 additional Pennsylvanians qualify for the rebate, and the almost 400,000 Pennsylvanians who already qualify for the program will see their rebates nearly double. More information will be provided when the changes go into effect next year.
